I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, and assume full responsibility for any medical or physical condition which may arise as the result of participation in the GOOMBAY INC. and B&G RISING STAR KICKERS TEEN TAKEOVER YOUTH KICKBALL TOURNAMENT . If, however, I observe any hazard during my presence or participation, I will remove my child from participation and bring such to the attention of the nearest GOOMBAY INC. and B&G RISING STAR KICKERS official immediately.
- RELEASE:** I unconditionally waive and release GOOMBAY INC. AND B&G RISING STAR KICKERS, its officers, agents, volunteers, and employees from any and all claims, rights, or causes of action which I now have or may have in the future for any injuries, expenses, loss of compensation, loss of service, or other damages which my CHILD may experience as a direct or indirect result of the use of the services, facilities, instruction, or premises of GOOMBAY INC. AND B&G RISING STAR KICKERS or, as a direct or indirect result of any act of negligence on the part of the CHILD or GOOMBAY INC. AND B&G RISING STAR KICKERS, including any act or failure to act.
- INDEMNIFICATION:** I unconditionally promise and agree to indemnify GOOMBAY INC. AND B&G RISING STAR KICKERS and its officers, agents, volunteers, and employees and to hold said persons harmless from any and all claims, rights, or causes of action which may be asserted against GOOMBAY INC.
