Furthermore, I release and discharge the client and World of Kids, Inc. and any and all persons acting for or on their behalf, of any and all liability whatsoever for blurring, distortion, alteration, optical illusion or composite form that may occur or be produced in the taking of any pictures or reproduction.

#### TERMS TO CLIENT:

Client and Advertising/Production Company agree to pay all fees set forth herein plus the agreed Agency Fee to World of Kids, Inc. Client and Advertising/Production Company's liability under this Agreement is joint and several. Payment terms: 30 DAY NET. All past due amounts shall accrue interest at the rate of 18% per annum. In the event World of Kids, Inc. obtains a judgment for any amounts due under this Agreement, the judgment shall accrue interest at the rate of 18% per annum.

The rates identified in this Agreement are for session fees only. Use of any photographs of Model and/or use of Model's likeness is strictly limited to the purpose(s) negotiated and agreed with World of Kids, Inc. Any additional or special use of any photographs of Model and/or use of Model's likeness, including but not limited to Video, Packaging, Billboards, Counter Cards, and similar special usage require separate negotiation with World of Kids, Inc. Client and Advertising/Production Company agree not to obtain or attempt to obtain any release from Model and/or Model's parent or guardian related to the use of any photographs of Model and/or use of Model's likeness unless such release has been pre-approved in writing by World of Kids, Inc. at least three (3) days prior to Booking.

Client and Advertising/Production Company agree that they shall not either individually, collectively, or in connection with any other individual or entity, use any photographs of Model and/or use Model's likeness for any purpose whatsoever until World of Kids, Inc. is paid in full.

All parties agree that this Agreement supersedes and takes priority over any other Agreement by, between, or among, Client, Advertising/Production Company, and Model. Client, Advertising/Production Company, and Model agree that no changes shall be made to this Agreement's terms or conditions without the express written agreement of World of Kids, Inc. World of Kids, Inc. expressly rejects any terms or modifications of terms by Model, Client or Advertising/Production Company, which purports to bind World of Kids, Inc.

World of Kids, Inc. and Model acknowledge that Model is a resident of the United States with a lawfully issued Social Security number and that Model is subject to United States rather than foreign taxes.

This agreement shall be governed by, construed and enforced in accordance with the laws of the State of Florida. The parties agree that the exclusive forum for any dispute arising out of or related to this Agreement, shall be the Federal or State Courts located in Miami-Dade County, Florida.

In the event that any provisions of this agreement shall be held invalid or unenforceable by any court of competent jurisdiction, such holding shall not invalidate or render unenforceable any other provision hereof.

In the event of litigation, the prevailing party shall be entitled to recover all reasonable attorneys' fees and costs from the other party for all levels, including pre-trial, trial, post-trial and appeal.
