Terms and Conditions

- The Classic Session fee is **\$75** and pays for time, artistic vision, and hosting of photos for up to 14 days for online ordering.

Proofs do not come with session. Your proofs will be online for viewing for up to 14 days. There will be a \$25 charge to keep photos up longer or to re host them at a later date. Print prices are separate from session fees.

In order to hold your appointment, the \$75 session fee must be received within **seven days** of booking your photo session. The money is non-refundable but the appointment can be rescheduled once if you have a scheduling conflict. Please notify me at least 48 hours before the photo session if you must reschedule. If the weather isn't agreeable on the day of the session, we will gladly reschedule to another day.

Images will be available approximately 14 days after your photo session in a password protected online gallery. You will be able to order your

photos from this gallery. There will be a minimum of 30 images to choose from.

We encourage you to share your online gallery with family and friends who may want to order, too.

Payment for any order is due in full when the order is placed. Captured Moments by Christi cannot accept partial payments. All orders placed will be ready within 2 weeks after payment is received (and checks cleared).

Images from your order will be kept on file for 6 months for additional reprints at a later date. There is a \$75 minimum for re-orders.

All images are to be inspected by you upon delivery. You have 2 days to make sure they meet your approval. After this period, **all sales are final**. There are no returns on prints. No exceptions.

A word about Copyright:

The Federal Copyright Law protects copyright. It is unlawful to copy or scan any images without permission of the photographer. Even though the pictures may be of you or your child, the photographer still owns the copyright to the image.

In order to control the quality of the work produced, the photographer is the only one who can crop, modify or order any image produced at this photo session.

The photographer retains the copyright and ownership of all images from the photo session and reserves the right to reproduce images for portfolio, studio display, gallery display, website, self-promotion, photo contests, etc.

Clients are not allowed to reproduce any images produced by the photographer for any purpose. Clients cannot authorize any reproductions of the images for commercial or personal use for photographic competition or display.

This includes scanning of work on Kodak picture makers or other printing/scanning machines at local stores (such as Wal-Mart, Walgreen's, CVS, etc.), or on home printers and scanners. Violators will be prosecuted.

No other camera or equipment other than the photographer's is allowed in the photo session.

Prices are guaranteed for a period of 30 days following the date of the portrait session. Items purchased more than 30 days after the date of the session will be priced from the most recent price list in effect.
