## MEMBERSHIP CLASSIFICATIONS AND DUES

- \* APPLICATION FEE—Required for all first-time Active, Additional Active and Non-Resident applicants. \$ 25.00
- 1. **ACTIVE** An individual of legal age who either resides in or works primarily in the state of Virginia, who is actively engaged in the profession of photography, videography, electronic imaging or other closely related fields may apply for membership in this category. This individual should derive a portion of his/her income from photography, image making or related activities. The studio or individual agrees to abide by all local regulations and the statutes of the Commonwealth of Virginia including but not limited to collecting and paying tax on all appropriate sales. Both a Virginia sales tax registration number and a portfolio of 6 unmounted 8x10 prints or a CD with 6 images reflecting the type and quality of images delivered to the clients are required. \$240.00
- 2. **ADDITIONAL ACTIVE**—All studios or establishments must have one Active member before others can apply in this category. It includes any individual who works with or for an Active member in creating images for clients. The sales tax number is the one listed for the Active Member. Applicants in this category must submit a portfolio of 6 images created by the applicant. The privileges are the same as the Active membership. \$215.00
- 3. **OFFICE STAFF**—All studios or establishments must have one Active member before others can apply in this category. Applicants in this category work with or for the Active member in a sales, accounting, IT or other studio support position, but do not create images for clients. No application fee is required. \$100.00
- 4. **PROVISIONAL**—An individual who is exploring the opportunity of making photography his/her primary vocation, a photographer whose work does not yet meet VPPA minimum standards OR a photographer who lacks any of the requirements for Active membership may apply in this category. This individual must either reside or work primarily in the state of Virginia. This membership has a limit of one year. Neither VA sales tax ID number nor application fee is required for this category. Privileges are limited. Anyone who currently sells his/her images whether or not it is the main source of income should apply in the Active category \$200.00
- 5. **NON-RESIDENT**—An individual of legal age actively engaged in the image making profession but who neither resides in nor routinely works in the state of Virginia, but who wishes to affiliate with the VPPA may apply for membership in this category. It is strongly encouraged that the applicant also be a member of the association in the state of his/her residence or employment. A VA sales tax number is not required in this category. \$190.00
- 6. **STUDENT**—An individual who can show that he/she is enrolled with a full course load in a recognized school, college or institute and has photography as the major program of study and is not yet earning a living in the field of photography is eligible for this category. Neither tax ID number nor application fee is required. A maximum of 4 years is the limit of eligibility for this category, and the classification will be reviewed each year. \$95.00
- 7. **RETIRED**—An individual no longer active in the image making profession may choose to have his/her Active, Additional Active or Nonresident membership classification changed to this category. \$95.00
- 8. **CORPORATE**—Any manufacturer, dealer of photographic supplies and materials, firm or provider of goods or services to professional image makers may apply in this category. Up to and including 3 representatives may attend all VPPA functions. There must be only one mailing address. Additional benefits listed on reverse. **\$495.00**
- 9. **SUPPORTING**—An individual NOT IN ANY WAY associated with the business of photography or professional image making may endorse the aims and objectives of the VPPA by applying in this category. Neither tax ID number nor application fee is required. \$75.00
