TIMESCALE All Member Juried Exhibition June 26 – July 24, 2015

ELIGIBILITY:

Entrants must be current CVA exhibiting members or must become CVA exhibiting members at the time of submission. Membership applications and renewal forms can be found on our website, www.greensboroart.org

JUROR:

Sarah Powers is the Executive Director at Visual Art Exchange, a non-profit in Raleigh NC dedicated to incubating emerging artists and connecting the community to the arts. VAE's major programs include exhibitions and continuing education for artists and SPARKcon, an interdisciplinary art and design festival and showcase. Prior to her tenure at VAE she directed the galleries at the Providence Art Club in Rhode Island for 4 years, and joined VAE after managing Donor Relations for Carolina Ballet. She is currently a member of the City of Raleigh Arts Commission, a board member for Triangle Art Works and the Downtown Raleigh Alliance and a past recipient of an Indies Art Award. She is also currently co-chairing the Cultural Plan for the City of Raleigh. Sarah is also an artist based in Raleigh, North Carolina whose mixed media work focuses on industrial and rural landscapes and landscape details. Powers is a graduate of Rhode Island School of Design and is represented locally by The Mahler Fine Art.

MEDIA:

Any traditional or nontraditional two dimensional or three dimensional medium or style, including but not limited to painting, drawing, photography, sculpture, printmaking, mixed media and digital media may be submitted for consideration. Work previously shown in any CVA exhibition will not be accepted. Artwork must have been completed in the past 24 months.

ENTRY PROCESS:

All work must be accompanied by a CVA inventory sheet (available online). **Each entry must be labeled on the back with name, title, price, and date artwork was created.** NOTE: Incomplete or illegible labels will result in rejection of work.

LIMITATIONS:

Artists may submit up to two (2) original works. Work must be submitted in person and cannot exceed 72 inches in any direction. Weight must not exceed 150 pounds. All work must be ready for exhibit: 2D work must be framed with secure hanging devices; 3D work must be suitably prepared with instructions for installation. Saw tooth hangers will not be accepted. All work on canvas must have finished edges. Work not gallery-ready, or not displaying good craftsmanship, will result in rejection.

NOTIFICATION OF WORK:

Selected artists will be listed on our website by June 21st after the jurying process has taken place. Please do not call the CVA Gallery to inquire if you have been accepted into the juried exhibition. **All work not accepted into the exhibition must be picked up on June 21st & 22nd. THERE ARE NO EXCEPTIONS; WORK NOT PICKED UP BY JUNE 26th WILL BECOME PROPERTY OF THE CVA GALLERY.**

NON-REFUNDABLE ENTRY FEE:

\$25 for 1-2 entries (current CVA Exhibiting Members)

\$75 for 1-2 entries (Non-Exhibiting Members -includes annual CVA Exhibiting Membership)

SALE OF WORK:

All work must be for sale. The CVA Gallery will retain a commission of 40% on all artwork sold during the exhibition.

First Place: \$300 & a solo exhibition

Second Place: \$200

The CVA reserves the right to reject any entry that is not suitable for display. The decision of the juror is final as to the selection and hanging of the pieces in the show. The CVA will not refund membership fees to those that have not complied with these submission guidelines.
